Approval of Minutes of January 17, 2024 Council Meeting:

Mr. Walker moved and Mr. Carter seconded to approve the minutes as presented. Motion carried.

Treasurer's Report:

January/February: Mr. Emert stated he had reviewed the financial report and found everything to be in order. Mr. Walker moved and Mr. Jones seconded to approve the Treasurer's Report as presented. Motion carried. Mr. Hankins stated that the Budget Amendment for additional PDC funding is in the works for less than originally requested.

Report of Officers, Committees & Executive Director:

Chairman's Report: There was none.

Executive Director Monthly Activities Report: Ms. Foster stated that a report was included in the Council packet. Ms. Foster stated that she attended the VACO/VML/VAPDC Local Government Day, VAPDC Meeting and visited General Assembly Delegate/Senate offices to support the increasing funding

for Virginia Planning Districts in Richmond. Ms. Foster stated that she met virtually with Bryan David, GOVAR3 Program Director, to discuss the CRC becoming the applicant for the Amelia County Regional Commerce Center Project. Ms. Foster stated that she assembled and submitted the requested CRC Budget request for FY 24-25. Ms. Foster stated that Ms. Hall, Finance Director, resigned on February 1st. Ms. Foster stated that she has started advertising for Finance Director and has received two applications.

Presentation of CRC FY 22-23 Audit: Ms. Foster stated that we had to complete a single audit due to additional federal funds through the VATI grant. Ms. Foster stated that it was discovered during the Audit that the VATI funds were not federal funds but instead state allocated funding therefore the single audit was not required. Ms. Foster welcomed Mrs. Robin Jones, CPA, CFA – Creedle, Jones, & Associated, P.C, to provide a presentation of the FY 2022 -2023 Audit. Ms. Foster stated that she has provided each person with a copy of the audit. Mrs. Jones stated that she would provide a brief overview of the Audit. Mrs. Jones that there was a clean opinion on the Audit. Mrs. Jones stated that the net position was \$442,639 and the only liability was the net pension of \$336,000. Mrs. Jones stated that the total assets are \$891,533. The net change in fund balance was \$114,752. Mr. Hankins moved and Mr. Carter seconded to approve the Audit as presented. Motion carried.

Scoping the Future - Discussion of Innovative/Regional Ideas: There was none.

Old Business:

Staff Monthly Project Reports:

Update on Regional Emergency Planning Activities: Mr. Fortune stated that a report was included in the Council packet. Mr. Fortune stated that after evaluating different options with the Project Management Team, it was decided to deliver educational materials and emergency kits to local emergency managers for distribution to citizens. Mr. Fortune stated that distribution is currently underway. Every county will receive 50 kits, with each kit containing 71 items and multiple information packets. Mr. Fortune stated that local distributions for Nottoway and Cumberland are pending. Mr. Fortune stated that the educational campaign is underway. The CRC staff is in the process of coordinating with local superintendents and school staff in each public school system in the region, plus the heads of school and school staff for the private schools in our region. The CRC plans to deliver Pedro the Penguin preparedness activity books to each elementary school in late March for distribution to second grade students. The second-grade students would then be able to take the books home and complete the activities during spring break as a fun way to learn about emergency preparedness.

Update on Watershed Implementation Plan (WIP) Phase III: Ms. Jones stated that a report was included in the Council packet. Ms. Jones stated that CRC staff has been researching and sending along grant opportunities to localities including the Virginia Department of Forestry's Virginia Trees for Clean Water Grant Program. Ms. Jones stated that the Town of Kenbridge is looking to apply to this grant program. The CRC will be assisting the Town with an application. Ms. Jones stated that she has emailed Lunenburg and Cumberland Counties extension office to discuss a potential rain barrel workshop within the Counties.

Update on Charlotte County Comprehensive Plan Update: Ms. Jones stated that a report was included in the Council packet. Ms. Jones stated that the CRC met with the Charlotte County Board of Supervisors on December 11th for a work session to provide a brief overview of the plan and address any board member concerns about the Plan. Board members posed questions regarding whether or not language on the solar cap can legally be included in the plan. Ms. Jones stated that the board was notified at their January meeting that solar cap language can legally be included in the plan. The board selected to change the recommended solar language and lower the cap to four percent. Ms. Jones

stated that at the February Board meeting the Board selected to set the public hearing date to April 10th. Mr. Jones asked if the solar cap language caps the number of solar projects on open land? Ms. Jones stated that it is for all acres in the County. Mr. Witt stated that SB 697 is still being reviewed. Mr. Witt stated that if this bill is passed the language included within this Bill would take away the localities right to approve or disapprove solar projects until four percent of the County's total acreage covered in solar panels has been approved. Mr. Witt stated that the percentage of the County's total land mass would not begin to be counted until after July 2024, therefore allowing solar projects to be approved above the four percent of the County's total land mass without the local government approval process. Mr. Bowen stated that Nottoway County is proposing an 800-foot setback on all Solar projects. There was discussion on how this bill could affect the county's solar zoning ordinances if passed.

Update on Buckingham County Comprehensive Plan Update: Mr. Fortune stated that a report was included in the Council packet. Mr. Fortune stated that CRC staff attended the Planning Commission work session on February 20th. CRC staff reviewed revisions to draft Section 2 and Section 3 of the plan, reviewed the citizen survey results, and Draft Section 4 with the Commission. The Planning Commission was scheduled to hold their next work session with the CRC on March 18th. Mr. Fortune stated that CRC staff are working on the requested changes.

Update on Amelia County Comprehensive Plan Update: Mr. Fortune stated that a report was included in the Council Packet. Mr. Fortune stated that CRC staff are working with County staff and the Planning Commission on revising the Future Land Use map. A draft map was presented to the Commission for review. The Commission requested a second option, which CRC staff are working to develop and will present to the Commission for review at its meeting on February 26th.

Update on Lunenburg County Comprehensive Plan Update: Mr. Henderson stated that a report was included in the Council Packet. Mr. Henderson stated that the CRC held a kick-off meeting for the working committee on Thursday, February 8, 2024. CRC staff presented and distributed information on the existing CRC Comprehensive Planning Process. Mr. Henderson stated that topics that were covered included the timeline, community meetings, and updating the plan with minimal changes. In addition, the committee brainstormed about special issues including broadband, solar, changing housing market, attracting major industries, solid waste transit, and outdoor recreation. Mr. Henderson stated that the next meeting is scheduled for Thursday, March 7th. At this meeting, the committee will discuss likes/dislikes from the previous plan in more detail and the CRC staff will discuss logistics of the community meeting(s).

Update on CRC Affordable Workforce Housing Development Program: Ms. Jones stated that a report was included in the Council packet. Ms. Jones stated that the CRC has a remaining \$320,357.46 in grant funding that has not been obligated to a housing partner or CRC staff time. The CRC is seeking experienced housing partners to establish affordable workforce housing units in the counties of Amelia, Cumberland, and Buckingham by June 30, 2025. These counties were not previously served by the first round of grant funding. She stated that applications are due by Wednesday, February 28, 2024. Mr. Walker asked if Charlotte was included in the last round of grant funding. Ms. Jones stated that Charlotte was included. Mr. Jones asked if these was an income limit. Ms. Jones stated that yes, there is an income limit. An individual would need be at or below 80% Area Median Income to be eligible to purchase or rent a housing unit. Ms. Jones stated that Piedmont Habitat's contractor and volunteers are currently working to complete the remaining work on the two homes on California Street in Crewe. Piedmont Habitat is working with the homeowners and the USDA Rural Development Loan office to close on the Andrew Drive homes in Farmville. Smyth Properties has noted that all seven housing units in Kenbridge are complete and have received the Certificate of Occupancy. The Smyths are currently accepting rental applications for these housing units. Ms. Jones stated that the Town of Blackstone's

contractor has completed siding on one of the two homes. The Town has completed water, sewer, and electricity connection to both homes. She stated that the contractor was hired to build both homes and is currently completing the builds simultaneously. Ms. Foster stated that our intent with this recently released round of funding is to cover all of our Counties. Ms. Foster stated that if we have any funds left over from this next round of funding we will rerelease the funding and open it to all of our counties.

Update on Kenbridge and Charlotte County Emergency Supplemental Historic Preservation (ESHP) Fund Projects: Ms. Jones stated that a report was included in the Council packet. The CRC is assisting the Town of Kenbridge and Charlotte County with grant-funded projects through the Department of Historic Resources to make repairs to historic structures that were damaged by Hurricane/Tropical Storm Michael. Ms. Jones stated that the Kenbridge Town Hall Repairs Project has been closed out. The CRC and Town staff have been in communication with DHR staff in regards to the final preservation agreement and is working on finalizing these documents. Ms. Jones stated that CRC staff worked with County staff to assemble and submit any final reimbursement requests and to set up a final site visit with DHR staff. The final site visit was completed on February 14, 2024.

Update on VATI Grant for Cumberland, Lunenburg, and Prince Edward: Mr. Fortune stated that a report and map was included in the Council packet. The CRC was awarded a grant by DHCD through the Virginia Telecommunication Initiative (VATI) program to provide funding to Kinex Telecom to complete a fiber buildout in part of Cumberland County, all of Prince Edward County, and part of Lunenburg County. Mr. Fortune stated Kinex and their crews have resumed work on laying fiber in Lunenburg County. Mr. Fortune stated that Kinex has advised that crews are working with VDOT on strategies to avoid old culvert lines. Mr. Fortune stated that CRC staff have requested an extension on the period of performance for the grant due to guidance form Kinex that they do not expect to have the work completed by the current end date. The CRC has requested a new end date of June 14, 2026 for the grant. Mr. Fortune stated that as of February 1, 2024, a total of 4,121 passings and 872 installs for new customers have been completed. Mr. Fortune stated that the CRC are scheduled to complete another site visit in March 2024.

Update on Drakes Branch SLFRF Projects: Ms. Foster stated that a report was included in the Council packet. Ms. Foster stated that the water metering project is complete. Ms. Foster stated that CRC staff have met with the Town Mayor and Clerk to review additional projects to expend the remaining funds. The Town will be working to prioritize projects and will be meeting again in March to discuss updates.

Update on Drakes Branch Building Acquisition Project: Mr. Fortune stated that report was included in the Council packet. The CRC is assisting the Town with implementation of a Hazard Mitigation Grant Program grant from FEMA through VDEM to fund the acquisition and removal of nine buildings in the Town's Central Business District. These buildings are located within the floodplain and are subject to periodic flooding. Mr. Fortune stated that the Town has retained Hurt and Proffitt to conduct lead and asbestos inspections of buildings 2 and 3. The inspections are underway and scheduled to be complete by late February/early March. These inspections need to be done before the demolition/clearance work can be bid out. Mr. Fortune stated that the Building 4 owner has selected to participate and has signed the agreement to sell the property to the Town. Mr. Fortune stated that the sale is pending completion of the sale agreement and supporting paperwork. Mr. Fortune stated that buildings 5 and 6's owner has agreed to the terms on a sale of the property to the Town. The Town is working with the Town Attorney and the property owner to complete the sale of these properties. Mr. Fortune stated that building 8 property has a tax lien. Mr. Fortune stated that the County has referred the property to Tax Authority Consulting Services (TACS) in Henrico County-based firm that assists local

governments in collection, bankruptcy, and assessment matters, for a tax sale on the property. Mr. Fortune stated that TACS has filed paperwork in Charlotte County Circuit Court to begin the sale process, and is working to appoint a Guardian ad Litem. Mr. Fortune stated that the building 9 property owner has agreed to terms on a sale of the property to the Town. The Town is working with the Town Attorney to close on the sale.

Update on Blackstone Armory VBAF Grant: Mr. Fortune stated that there is not a report in the Council packet. The CRC is assisting the Town with implementation of a Virginia Brownfields Assistance Fund (VBAF) grant through VEDP to undertake asbestos abatement, underground tank removal, and lead abatement at the Harris Memorial Armory Center in Blackstone. Mr. Fortune stated that all abatement/removal activities are complete. The CRC assisted the Town in preparing and submitting the required reporting and financial documentation to VEDP on October 5, 2023. Mr. Fortune stated that the consultant used by VEDP to review submittals under this program requested additional information. CRC staff worked with the Town and their project inspector to provide to the additional information to VEDP and their consultant on February 5, 2024. Mr. Fortune stated that the Town is still waiting on a response.

Update on CRC Hazard Mitigation Plan Update: Mr. Fortune stated that a report was included in the Council packet. Mr. Fortune stated that CRC staff has been working with VDEM and FEMA Region 3 staff, Lunenburg County staff, and representatives from Southside Electric Cooperative (SEC) on how to address the project submitted by SEC for mitigation funding. Mr. Fortune stated that there are two options to address this: Add SEC as a participant to our Regional Plan, which would require significant changes to the draft Plan; or amending on of Lunenburg County's mitigation actions to make this project eligible, which would require the County to act as applicant and (if funded) grantee for the project. As of today, CRC staff was in communication with Lunenburg County staff and SEC representatives to determine the preferred option. Mr. Fortune stated that there are currently four known mitigation funding applications from this region that are being held by VDEM until preliminary approval of our Plan has been granted. Mr. Fortune stated that based on the information received to date from SEC about the project, Lunenburg County was not comfortable actin as the applicant or grantee for the project. Therefore, after consulting with VDEM staff and given the amount of time it would take to add SEC as a participant to the plan, the decision was made to go ahead and submit the plan to FEMA Region 3 staff for preliminary approval.

Update on SEED Innovation Hub Project: Ms. Jones stated that a report was included in the Council packet. The CRC is assisting the Longwood Real Estate Foundation (REF) in implementation of three grants that were awarded to the REF for the completion of the SEED Innovation Hub. Grants are from the U.S. EDA, the Tobacco Commission, and GO Virginia (GOVA). Ms. Jones stated that on January 25th, LUREF held a public bid opening with two submitted bids from Kenbridge Construction and English Construction. Ms. Jones stated that the CRC is assisting LUREF with providing the EDA with the necessary documentation that is required for the final approval of the lowest bidder.

Update on CRC GO Virginia Grant – Development of Business Plan and Strategy for NEW REDO: Ms. Foster stated that a report was included in the Council packet. Ms. Foster stated that at the last Council meeting the Council selected to determine dues for the new CRC REDO based off a \$2.50 per capita model. Ms. Foster stated that the CRC did not discuss how Longwood would be included in this model. There was discussion. Mr. Emert stated that Longwood should contribute at a flat rate of \$25,000 (minimum rate). Ms. Foster stated that originally the CRC was planning on utilizing an unpaid student intern to assist with the administrative support to Convergent. Ms. Foster stated that she was informed that unpaid internships are unlikely option stating that many students are looking for a paid internship experience. Ms. Foster stated that the CRC has a surplus of salary funds that were originally

budgeted for the Regional Planner position, as it took longer than anticipated to hire the position. Ms. Foster stated that she would propose that the Council hires a part-time person to work 15 to 20 hours a week at \$15 to \$18 per hour. Ms. Foster stated that this person would work from March till June. Mr. Hankins moved and Mr. Jones seconded to request public investment dues for the creation of the Virginia's Heartland Regional Economic Development Alliance to Longwood University for a flat investment rate of \$25,000 (minimum rate) and that the CRC can begin to advertise to hire a part-time person to work 15 to 20 hours a week at \$15 to \$18 per hour to assist the Consultant on the Fundraising Campaign. The motion carried.

Central Virginia Poultry Cooperative: Mr. Foster stated that a report was included in the Council packet. Ms. Foster stated that due to this project being an ongoing Economic Development project, the TRRC cannot make a comment at this time.

Council Member Comments: Mr. Emert stated that the Executive Director Search Committee met prior to the Council meeting. Mr. Emert stated that the committee has advised staff to advertise for the Executive Director position. The Committee would like for the new Executive Director to begin by May 1, 2024.

New Business:

Staff Reports

Update on Grant Writing: Ms. Jones stated a copy of the grant writing report was included in the Council packet. Ms. Jones stated that the CRC is assisting the Town with an application to the SCRC, State Economic Infrastructure Development Grant Program to fund construction costs for the renovation and rehabilitation of the Harris Memorial Armory. Ms. Jones stated that the CRC is assisting Prince Edward County to apply for a US DOT RAISE Planning Grant to complete a Farmville US 460 East Interchange Study. Ms. Jones stated that the CRC is assisting Virginia Food Works with a AFID planning grant application to purchase a new liquid goods filling machine and dry goods filling machine for the Prince Edward Cannery that would serve local food producers. Ms. Jones also stated that the CRC is assisting PSR with an application to purchase a vehicle through the USDOT FTA, Innovative Coordinated Access and Mobility grant program. Ms. Jones stated that the CRC is also assisting Victoria Fire and Rescue, Blackstone VFD, Keysville VFD, Kenbridge VFD, and Prince Edward County with applications to the Assistance to Firefighter Grant Program.

Virginia Department of Health, Office of Emergency Medical Services (OEMS) Update on Rescue Squad Assistance Fund Grant delays: Ms. Foster stated that the letter from the Office of Emergency Medical Services (OEMS) is included in the Council Packet. Ms. Foster stated that the OEMS is continuing to focus on financial restructuring. Because of this, the OEMS will not be funding Rescue Squad Assistance Fund (RSAF) grants for the upcoming Spring 2024 grant cycle and therefore will not be taking new applications. Ms. Foster stated that as noted in the letter the incoming "4 for Life" program funds will be used to fund grants previously obligated. Ms. Foster stated she spoke with VDH staff and they are expecting to have the next grant round by Fall 2024.

Update on Request for Additional Planning District Funding: Ms. Foster stated that there was not a report included in the Council packet. Ms. Foster stated that there was no additional State funding for PDCs included in the Governor's released budget. VAPDC worked with legislators to introduce a budget amendment that would give each PDC an extra \$150,000 in funding. Ms. Foster stated that currently there is an amendment that would provide \$75,000 in additional PDC funding. However, this amendment is not carried by both the House and the Senate.

Council Member Comments: There were none:

Commonwealth Intergovernmental Review Process (CIRP): There were no comments.

Other Business: There was none.

Council Member Comments: There were none.

Adjournment, Next Meeting: The meeting adjourned at 10:02 a.m. The next meeting was set for Wednesday, March 20th, at the CRC's office located at the Heartland Building in Keysville, Virginia.

Update on Regional Emergency Planning Activities

As you are aware, the CRC was awarded a State Homeland Security Program (SHSP) grant in November 2022 to fund community outreach and preparedness activities related to disaster and emergency preparedness. This grant was funded under one of the FEMA National Priorities, Community Preparedness. Consequently, FEMA placed on hold on these funds at the time of award. That hold was released on May 16, 2023.

Update: The educational materials and emergency kits have been delivered to local emergency managers in each county for distribution to citizens. Every county received 50 kits, with each kit containing 71 items and multiple information packets. Local distributions have occurred in Ameila, Buckingham, Charlotte, Lunenburg, and Prince Edward Counties. Local distributions for Cumberland and Nottoway Counties are pending.

The educational campaign is underway. CRC staff have been coordinating with school superintendents and school staff in each public school system in the region, plus the heads of school and school staff for the four private schools in our region. As of today, staff have been in touch with all the schools except for one private school. CRC staff have begun scheduling delivery of Pedro the Penguin preparedness activity books to each elementary school for distribution to second grade students during the month of March. The second-grade students would then be able to take the books home and complete the activities during Spring Break, which is in early April for most of the schools in the region, as a fun way to learn about emergency preparedness.

NOTE: The current end date for this grant is June 30, 2024. Given the delay in getting this grant under contract, the CRC considered requesting an extension of this deadline. However, CRC staff believe we can complete distribution of the educational materials in the Spring 2024. Therefore, an extension on this grant will not be needed.

As you are aware the CRC has received \$2 million in grant funds from Virginia Housing to establish 20 affordable and workforce housing units in the CRC region **over a 48-month period (extended to June 30, 2025)**. CRC staff time on the project is also covered by this grant award.

Project: The Affordable Workforce Housing Development Program has established three housing partners: Piedmont Habitat for Humanity, Smyth Properties, and The Town of Blackstone. Piedmont Habitat will be installing 11 modular homes in the Towns of Farmville, Keysville, and Crewe. Smyth Properties will be establishing seven (7) units for lease through adaptive reuse of downtown properties in Kenbridge. The Town of Blackstone and their partner, Southside Outreach, will be building three (3) homes in Blackstone for home ownership. Through these partners the CRC has been able to establish 21 affordable housing units.

Update: The CRC has a remaining \$320,357.46 in grant funding that has not been obligated to a housing partner or CRC staff time. The CRC is now seeking funding applications from Experienced Housing Partners to establish affordable workforce housing units in the counties of Amelia, Cumberland, and Buckingham by June 30, 2025. These counties were not previously served by the first round of grant funding. Applications were due by Wednesday, February 28, 2024. We received three applications. CRC staff are currently reviewing the applications.

- Piedmont Habitat Piedmont's contractor and volunteers are currently working to complete the remaining work on two of the homes on California Ave in Crewe. The project is expected to be completed in April 2024. All the Andrew Drive homes in Farmville have been completed. Piedmont Habitat is working with the homeowners and the USDA Rural Development loan office to close on the Andrew Drive homes.
- Smyth Properties All seven housing units are complete. The Smyths are currently accepting rental applicants for these housing units. CRC staff attended a ribbon cutting in Kenbridge on March 1st for these properties.
- Town of Blackstone/ Southside Outreach The contractor was hired to build both homes and is currently completing the builds simultaneously. The drywall has been hung for both homes.

Town of Kenbridge and Charlotte County Project Update

DATE: March 4, 2024

Project: The CRC is assisting Charlotte County and the Town of Kenbridge with grant administration of the two grant funded projects.

Project Synopsis: Kenbridge Town Hall Repairs project – grant funds will be utilized to repair the Kenbridge Town Hall which was damaged during Hurricane Michael. Charlotte County Courthouse Complex Drainage project – grant funds will be utilized to address moisture issues for the Charlotte Courthouse Complex that flooded and was damaged during Hurricane Michael.

Project Update:

Kenbridge Town Hall Repairs Project – The contractor, Harris and Sons, has completed the remaining painting and carpentry work on the Town Hall building (only a small portion of the carpentry work will be covered by this grant). This grant has been closed out. The CRC and Town Staff have been in communication with DHR staff in regards to the final preservation agreement, which will be recorded at Lunenburg County's Deed office. CRC staff has been working with DHR staff to finalize the preservation agreement.

<u>Charlotte County Courthouse Complex Drainage Project</u> –All work for the project has been completed. CRC staff worked with County staff to complete a final site visit with DHR staff. The final site visit was completed on February 14, 2024. The CRC completed and submitted the final close out report. The CRC and County Staff have been in communication with DHR staff in regards to the final preservation agreement, which will be recorded at Charlotte County's Deed office.

**The Emergency Supplemental Historic Preservation Funds (ESHP) were only available through the Department of Historic Resources to localities that suffered historic property damage due to Hurricane Michael. Localities had to be listed in the Hurricane Florence and/or Hurricane Michael Major Disaster Declaration to be eligible for assistance.

Project: CRC VATI grant for the expansion of broadband in Cumberland, Lunenburg, and Prince Edward Counties. The project involves working with Kinex Telcom, a local internet service provider.

Update:

- Kinex and their contractors continue to work on laying down middle-mile fiber in unserved areas of all three counties.
- Kinex crews are working in parts of all three counties where middle-mile fiber is in place to complete installations for new customers. James Garrett, Kinex Telecom, has advised that Kinex continues to work on addressing the existing backlog for new installations.
- Mr. Garrett has advised that Kinex filed a challenge to DHCD on an application from Firefly
 to connect VATI-eligible customers in Cumberland County. The challenge involves 239
 houses. Kinex is challenging on the grounds that they have fiber within 1,000 feet of these
 houses.
- The CRC was granted an extension on the period of performance for the grant. The extension was requested after Kinex advised that they do not expect to have the work completed by the original end date (June 14, 2025). The new end date for the project is June 14, 2026.
- As of March 2, 2024, a total of 4,394 passings (out of a target of 11,397 total passings) and 1,028 installs for new customers have been completed.
- The Project Management Team meets monthly to discuss the project. The team includes local staff, CRC staff, Kinex staff, and DHCD staff. The next meeting is scheduled for March 8, 2024.
- Per an agreement with DHCD, CRC and local staff will be making periodic site visits to observe the work being done by Kinex and their contractors. CRC and Cumberland County staff conducted a site visit on Route 45 in Cumberland County on March 5, 2024 to observe middle mile installation. CRC staff also visited a site in Prince Edward County the same day where a new customer installation was taking place.





As you may recall, the Town of Drakes Branch has been awarded a Hazard Mitigation Grant Program (HMGP) grant by FEMA through VDEM to fund the acquisition and removal of nine (9) buildings in the Town's Central Business District. These buildings are located within the floodplain and are subject to damage from flood events in the area. The HMGP grant is being matched with a combination of funds from the State and local matching funds from the Town. The CRC is assisting the Town with the implementation of this project.


Update:

- Building 1: Privately owned property
 - o The property owner has opted out, and will not be participating in the project.
- Buildings 2 and 3: Old Town Hall and fire station
 - o Appraisals completed.
 - o Title searches completed.
 - The Town has retained Hurt & Proffitt (H&P) to conduct lead and asbestos inspections of these properties. They have completed the interior inspections, and still need to inspect the roofs. H&P has advised that they were delayed by weather and hope to have the roof inspections completed by late March. These inspections need to be done before the demolition/clearance work can be bid out.
- Building 4: Privately owned property
 - o Appraisal completed.
 - o Title search completed.
 - The owner has signed an agreement to sell the property to the Town. The sale is pending completion of the sale agreement and supporting paperwork.
 - This property has a deed of trust per the title search, which will need to be settled as part of the sale process.
 - The Town has retained Hurt & Proffitt to conduct a lead and asbestos inspection of this property. They have completed the interior inspection, and still need to inspect the roof. H&P has advised that they were delayed by weather and hope to have the roof inspection completed by late March. This inspection needs to be done before the demolition/clearance work can be bid out.

- Buildings 5 and 6: Privately owned, adjoining buildings, same owner
 - o Appraisals completed.
 - o Title searches completed.
 - The owner has agreed to terms on a sale of the property to the Town. The Town is working with the Town Attorney and the property owner to complete the sale of these properties.
 - The Town has retained Hurt & Proffitt to conduct lead and asbestos inspections of these properties. They have completed the interior inspections, and still need to inspect the roofs. H&P has advised that they were delayed by weather and hope to have the roof inspections completed by late March. These inspections need to be done before the demolition/clearance work can be bid out.
- Building 7: Privately owned property
 - o Property owner has opted out, and will not be participating in the project.
- Building 8: Privately owned property
 - o Appraisal completed.
 - o Title search completed.
 - O Property has tax liens. The County has referred the property to Tax Authority Consulting Services (TACS), a Henrico County-based firm that assists local governments in collection, bankruptcy, and assessment matters, for a tax sale on the property. TACS has filed paperwork in Charlotte County Circuit Court to begin the sale process, and a decree of sale hearing has been scheduled for April 24. Once a decree is entered by the Circuit Court Judge, the next step is to schedule the sale. Staff from TACS has advised that the sale would likely occur sometime in June.
 - The Town has retained Hurt & Proffitt to conduct a lead and asbestos inspection of this property. They have completed the interior inspection, and still need to inspect the roof. H&P has advised that they were delayed by weather and hope to have the roof inspection completed by late March. This inspection needs to be done before the demolition/clearance work can be bid out.
- Building 9: Privately owned property
 - o Appraisal completed.
 - o Title search completed.
 - o The sale of this property has been completed.
 - The Town has retained Hurt & Proffitt to conduct a lead and asbestos inspection of this property. They have completed the interior inspection, and still need to inspect the roof. H&P has advised that they were delayed by weather and hope to have the roof inspection completed by late March. This inspection needs to be done before the demolition/clearance work can be bid out.

Grant: Asbestos Remediation/Lead Abatement/Tank Removal

As you may recall, the Town of Blackstone has been awarded a Virginia Brownfields Assistance Fund grant by the Virginia Economic Development Partnership (VEDP) to undertake asbestos and lead abatement activities, as well as removal of an underground fuel tank, at the Harris Memorial Armory Center. The Armory is being rehabbed for use as a multi-purpose facility, which would include job training programs to train workers for jobs in the hospitality industry. The CRC is assisting the Town with the implementation of this grant.

Update: All abatement/removal activities are complete. The CRC assisted the Town in preparing and submitting the required reporting and financial documentation to VEDP on October 5, 2023. The consultant used by VEDP to review submittals under this program requested additional information, which the CRC provided. Upon a review of the additional information by the consultant, VEDP informed the CRC and the Town February 23, 2024 that all submittals had been approved and VEDP was processing the grant reimbursement. Subsequently, on February 29, 2024, VEDP made the grant reimbursement to the Town via electronic funds transfer and the grant was closed out.

Project: CRC GO Virginia Enhanced Capacity Building Grant to fund a business plan & strategy for the creation of a NEW CRC (footprint) Regional Economic Development Organization (REDO) in partnership with Longwood University. The CRC hired a consultant team in March 2023: Creative Economic Development Consulting, Timmons Group/Mangum Economics and Convergent Nonprofit Solutions to assist the CRC staff, CRC REDO Working Committee and CRC Advisory Board in completing this feasibility project. This grant is complete and has been closed out. The results of the project concluded that a new REDO is a viable option. The new REDO – Virginia's Heartland Regional Economic Development Alliance (VHREDA) is being pursued by the CRC.

Update:

- The CRC at the January 17th Council meeting took action to allow the Executive Director to negotiate an agreement with Convergent Nonprofit Solutions, LLC to proceed with the Fundraising Campaign for VHREDA (the new REDO). The CRC would support the monthly costs upfront and be reimbursed by membership dues or by private pledges received for VHREDA.
- The CRC also determined dues for VHREDA would be based on \$2.50 per capita with Longwood University paying the minimum of \$25,000 for a total of \$278,573 in public investment funds.
- The CRC signed an agreement with Convergent to begin the Fundraising Campaign for the VHREDA on April 1, 2024.
- The CRC has advertised for a part-time administrative support for the VHREDA fundraising campaign. So far, we have no applicants.
- The VHREDA Private Investment Campaign Kick-Off Meeting will be held the first week of April (date TBD). The County Administrators and Longwood University will be participating in this meeting.
- VHREDA Public Investment requests to all seven counties and Longwood University have been sent out.

Establishing VHREDA as a 501c3

I contacted Crystal Morphis, Creative Economic Development Consulting, to determine the steps for establishing the VHREDA as a 501c3. VHREDA will need to complete incorporation documents with the state and IRS. Filling for nonprofit status happens with the IRS after it is incorporated. Crystal recommended we engage an attorney to do this – one with experience incorporating nonprofits for economic development specifically. There is specific language that the IRS looks for when considering a 501c3 application for economic development. Legal fees may range \$6,000-\$9,000. The IRS approval process may take a few months to possibly up to nine months. Regarding fundraising, Crystal advised VHREDA can begin accepting funds with the IRS application pending.

Action – Request the CRC Executive Director to employ an Attorney to begin this process.

The Commonwealth Regional Council has been assisting the Central Virginia Poultry growers since May of 2024 to find solutions for farmers who were affected by the Tyson closure in Glenn Allen, Virginia. The growers came up with a solution – the creation of the Central Viginia Poultry Cooperative (CVPC). The Central Virginia Poultry Cooperative was created and has entered into an agreement with Dutch Country Organics, LLC of Middlebury, Indiana. CVPC will raise and sell wholesale cage-free and other premium table eggs to Dutch Country LLC. Profits will be reinvested in people, products, processes, and member dividends. Local grain purchases will benefit local grain farmers, the community.

The CRC was able to assist CVPC in obtaining the following grants to assist with the start-up costs of the CVPC. The CRC is serving as the applicant and fiscal agent:

Governor Youngkin Announces State Support for New Poultry Cooperative

Central Virgina poultry farmers form new cooperative and transition from broilers to egg production with Dutch Country Organics agreement

RICHMOND, VA – Governor Glenn Youngkin announced the formation of the Central Virginia Poultry Cooperative, Inc., by a group of poultry farmers who were affected by the closure of the Tyson Foods broiler facility in Glen Allen. The farmerowned cooperative will produce and sell wholesale cage-free, premium table eggs to Dutch Country Organics, LLC of Indiana. Cooperative profits will be reinvested in people, products, processes, and member dividends. Establishment of the cooperative restores and revitalizes poultry production in Central Virginia for the benefit of poultry-dependent farms and communities through the production of eggs.

"When we learned last March that poultry farmers in Central Virginia needed our help, I directed our Secretary of Agriculture and Forestry to bring a team together and find a way forward for the family-owned farms of the region," said Governor Glenn Youngkin. "I am thrilled to share that less than a year later; the Commonwealth is supporting many of these growers in making a bold step forward to a brighter future in the fast-growing market for cage-free eggs."

"I commend the team of public and private entities that rolled up their sleeves, went to work and played a role in the formation of the Central Virginia Poultry Cooperative and getting the poultry producers in this region farming again," said Secretary of Agriculture and Forestry Matthew Lohr. "Virginia poultry farmers produced nearly 62 million eggs in 2022 and I look forward to seeing that number eclipsed in the future, thanks to the family farms in Central Virginia and Dutch Country Organics."

Dutch Country recently executed a multi-year agreement with the Central Virginia Poultry Cooperative. Details of the agreement have not yet been released. The cooperative expects to place the first laying hens in members' converted broiler houses in April 2024.

"Central Virginia Poultry Cooperative, Inc. was formed with the hope of returning the poultry growers of Central Virginia back to farming. We have been able to achieve this with help from many individuals and organizations," said Central Virginia Poultry Cooperative President John Bapties. "The Co-op and its members would like to express our gratitude to all the state and local agencies who have helped us during the last year. We would also like to thank Dutch Country Organics for giving us this new farming opportunity."

Founded by Lamar Bontrager, Dutch Country Organics, LLC is an Amish-owned specialty egg business based in Middlebury, Indiana. Operating under the highest standards of animal welfare practices, the company contracts with over 50 local Amish farm families to produce a variety of high-quality, fresh, cage-free, and other specialty table eggs. Through established contracts, Dutch Country eggs are sold to national

retailers such as Costco, Albertsons, Target, Aldi, Walmart, and Kroger, the largest and second largest retail buyers of U.S. eggs respectively.

"We look forward to our new relationship with the Central Virginia Poultry Cooperative and its family farm members. The family farm is our story. It's what we support. It's what we encourage. The family farm, where fresh, natural eggs come from fresh, clean environments," said Bontrager, Dutch Country Organics CEO. "At Dutch Country Organics, we promote the family farm, where families work together to provide a place that hens can live and roam, doing what comes naturally to them. Healthy and happy hens produce eggs that are healthier, too. And that's good for all of us."

"I am pleased the Commission was an early and strategic partner in helping to stand-up this important new farmer-owned cooperative and that through the coordinated support of the state and key partners like the Virginia Farm Bureau we are enabling these farmers to have control over this business and their livelihoods. This cooperative will also have a positive impact on agriculture in our region beyond the cooperative itself and I am particularly interested in working with the cooperative to see if we can prioritize the use of locally farmed grain. A win for farmers is a win for the Commonwealth and our ability to work together to support our family farms is going to have a lasting impact," said Virginia Tobacco Region Revitalization Commission member Richard Hite.

"Virginia Farm Bureau is proud to be a partner in this effort to restore poultry production in Central Virginia. Everyone involved has contributed a tremendous effort in a short amount of time," said Virginia Farm Bureau Federation President Wayne F. Pryor. "The Cooperative not only promises to return economic and employment opportunities to poultry and grain producers and their communities, but also represents a significant locally driven economic impact in the region."

"The Commonwealth Regional Council has been pleased to have assisted the Central Virginia Poultry Cooperative in applying for multiple funding sources to assist them in setting up the Cooperative," said Commonwealth Regional Council Executive Director Melody Foster. "The Cooperative is to be applauded for staying the course and not giving up on farming in south central Virginia."

The Virginia Department of Agriculture and Consumer Services (VDACS) worked with the Virginia Tobacco Region Revitalization Commission, Virginia Farm Bureau Federation, and the Commonwealth Regional Council to secure this project for the Commonwealth. The Commonwealth Regional Council serves Amelia, Buckingham, Charlotte, Cumberland, Lunenburg, Nottoway, and Prince Edward counties.

Governor Youngkin approved a \$50,000 grant from the Governor's Agriculture and Forestry Industries Development Fund, with the counties providing matching funds. The project is also receiving a \$1.4 million award from the Virginia Tobacco Region Revitalization Commission. The cooperative also is expected to receive an award of \$341,750 from the Rural Rehabilitation Trust Fund, which is administered by VDACS.

CRC Staff Update - Providing Grant Writing Services to Local Agencies

As per the CRC's ongoing efforts to provide grant writing services for County Public Schools, local government, law enforcement, and 501 (c)(3) organizations in the region, the following activities have taken place since February 13, 2024:

Status Update

- Tobacco Commission By Invitation Only: Congratulations to the Central Virginia Poultry Cooperative! The CVPC was awarded \$1,400,000 in funding to cover start-up costs to develop a Poultry Cooperative. The CVPC will be providing the dollar for dollar required match for this grant. The CRC was the applicant and will be the fiscal agent for funds.
- VDACS, AFID Planning Grant: Congratulations to the Central Virginia Poultry Cooperative! The CVPC was awarded \$35,000 in grant funding to cover start-up costs to develop a Poultry Cooperative. Amelia, Buckingham, Cumberland, Charlotte, Lunenburg, Nottoway, and Prince Edward Counties will be providing \$35,000 in required match (\$5,000 per County). The CRC was the applicant and will be the fiscal agent for funds.
- VDACS, AFID Infrastructure Grant: Congratulations to the Central Virginia Poultry Cooperative! The CVPC was awarded \$50,000 in grant funding to cover start-up costs to develop a Poultry Cooperative. Amelia, Buckingham, Cumberland, Charlotte, Lunenburg, Nottoway, and Prince Edward Counties will be providing \$21,000 in required match (\$3,000 per County). The remaining \$4,000 in required match will be matching through Tobacco Commission grant funding. The CRC was the applicant and will be the fiscal agent for funds.
- VDACS, Rural Rehabilitation Trust Fund: Congratulations to the Central Virginia Poultry Cooperative! The CVPC was awarded \$341,750.00 in grant funding to cover start-up costs to develop a Poultry Cooperative. The CRC was the applicant and will be the fiscal agent for funds.
- DHCD Affordable and Special Needs Housing Program: Congratulations to Piedmont Habitat for Humanity! Piedmont Habitat for Humanity, a non-profit based out of Farmville, was awarded \$623,203 in funding to partially fund the construction of five-homes on Ashley Way in Keysville. The CRC assisted with this application.
- VDACS, AFID Planning Grant: The CRC is assisting Virginia Food Works, a local non-profit, with a planning grant application to purchase a new liquid goods filling machine and dry goods filling machine for the Prince Edward Cannery that would serve local food producers. The planning grant applications are accepted on a rolling basis.

- VDOF, Virginia Trees for Clean Water grant: The CRC assisted the Town of Kenbridge with a submitted grant application to purchase and mulch 45 American Holly trees. These Holly trees will be planted at the soccer complex to screen the wastewater plant and the Town Park. Applications are accepted on a rolling basis.
- VDCJS, Byrne Justice Assistance Grant: The CRC is assisting Charlotte County Sherriff's
 Office with an application to purchase new body cameras for deputies. The application is due
 on March 13th.
- Assistance to Firefighters Grant (AFG): Applications were due on March 8th. The CRC assisted the following agencies with AFG applications:
 - o Victoria Fire and Rescue purchase a vehicle
 - o Blackstone VFD purchase an exhaust system
 - o Keysville VFD purchase breathing apparatus
 - o Prince Edward County (regional application) purchase radios

Awaiting Approval

- USDOT Federal Transit Administration (FTA), Innovative Coordinated Access and Mobility grant: The CRC assisted Piedmont Senior Resources with an application to purchase a vehicle. Applications were due on February 13th.
- Southeast Crescent Regional Commission (SCRC), State Economic and Infrastructure Development (SEID) Grant Program: The CRC assisted the Town of Blackstone with an application to fund construction costs for the renovation and rehabilitation of the Harris Memorial Armory. Applications were due on February 2, 2024.
- NPS, Save America's Treasures Grant: The CRC assisted Mary E. Branch Heritage Center with a submitted application to the renovate the historic Mary E. Branch Elementary School. Applications were due on December 1, 2023.
- VDOT, Ready, Set, Go: The CRC assisted the Town of Keysville with a submitted planning grant application to fund planning activities for a sidewalk project in Keysville.
- NPS, African American Civil Rights: The CRC assisted Cumberland Co. with submitting two applications to renovate and establish the historic designation for the historic Luther P. Jackson High School. The CRC also assisted Mary E. Branch Heritage Center/ Prince Edward County with a submitted application to renovate the historic Mary E. Branch Elementary School. Applications were due November 1, 2023.
- VDOT Transportation Alternatives Program (TAP): The CRC assisted Amelia County, Lunenburg County, the Town of Farmville and the Town of Keysville with pre-application submissions to fund the construction of pedestrian sidewalks. Lunenburg County and the Town of Farmville has selected to not submit a full application for the TAP. The Town of Keysville has been advised to pursue another VDOT grant opportunity. The CRC assisted Amelia County with the submission of a full TAP application. Applications were due October 2, 2023.

Projects on Standby (work undertaken as developments warrant)

• Better Days Farmville: CRC staff is working with Better Day Farmville, a local non-profit, to Ragey42 funding sources to purchase a new building for its operations.

- Lunenburg County: CRC staff is working with Lunenburg County to identify funding sources to expand the Tobacco Heritage trail.
- Town of Kenbridge: CRC staff is working with Lunenburg County and the Town of Kenbridge to identify funding sources to purchase a HVAC system for the Kenbridge Recreation Center.
- Cumberland County: CRC staff is working with Cumberland County to identify gap funding to complete a recreational trail between Bear Creek State Park and Court House Village.
- Nottoway County: CRC staff is working with Nottoway County to identify funding sources to assist with operation costs for the landfill.
- Drakes Branch Volunteer Fire Department: CRC staff is working with the Drakes Branch Volunteer Fire Department to identify funding sources for the purchase of turnout gear and breathing apparatus. CRC staff are looking into submitting a potential application to Firehouse Subs.
- Town of Keysville: CRC staff is working with the Town of Keysville to identify funding sources for the construction of a pickle ball court and public parking lot.
- Community Resource Services: CRC staff is working with Community Resource Services, a local non-profit, to identify funding sources for the construction of a new food pantry that would serve Lunenburg County. CRC staff are looking into submitting a potential application to the Sentra Health grant program that are estimated to open in the spring.
- Crewe Volunteer Fire Department: CRC staff is working with Crewe VFD to identify funding sources to purchase an iPad for the EMS Truck. CRC staff are looking into submitting a potential application to the CENTRA health grant program that are estimated to open on March 4th.
- Curdsville Community Center (Buckingham County): The CRC is working with the group to seek funding opportunities to renovate the community center.
- Playground Equipment Funding: The CRC is continuing to research funding for a playground equipment.
- Animal Shelter Funding: The CRC is continuing to research funding for new animal shelters.
- Twin Lakes State Park, Friends of Twin Lakes State Park: The CRC is working with the State Park and the non-profit group that supports the State Park to identify funding opportunities for various projects at the Park.

Update on VAPDC Additional State Funding Request

As you may recall, the Virginia Association of Planning District Commissions (VAPDC) put together a workgroup to work on submitting a request for an additional \$150,000 for each Planning District. This request was submitted to the Governor and requested to be included in his budget released in mid-December. Many of our localities provided letters of support, which were much appreciated. Unfortunately, no additional State funding was included in the Governor's released budget.

However, the VAPDC worked with legislators to put forward a budget amendment that was included in the approved FY24 State Budget. While a reduced amount, a \$25,000 (per PDC) increase has been included in the State Budget for FY25 and FY26.

Currently the CRC receives \$89,971 from the State (VA Regional Cooperation Act) for planning activities. This amount will increase to \$114,971 annually once the Budget is signed by the Governor and approved.

David Blount, VAPDC Executive Director is to be commended for his efforts in getting this budget amendment approved. Also, Mr. Hankins, who serves on the VAPDC Board of Directors, urged lawmakers to support this request and should be commended as well.
