# Opioid Abatement Initiatives Expand Across Region

CRC is supporting two new opioid recovery initiatives funded by the Virginia Opioid Abatement Authority (OAA):

- Piedmont Health District received \$150,000 to hire a Peer Recovery Specialist and a part-time coordinator to expand outreach, naloxone distribution, schoolbased education, and mobile clinics in Prince Edward and Nottoway counties.
- Piedmont Regional Jail was awarded \$50,000 to implement a peer-led recovery program modeled after the McShin Foundation. The program includes a 14-week recovery curriculum, re-entry preparation, and Medication Assisted Treatment (MAT).

Both programs aim to reduce overdoses, support recovery, and strengthen community-based prevention and treatment resources.

### **Environmental Initiatives & DEQ Partnerships Underway**

CRC is advancing several regional environmental projects in coordination with state and local partners:

- Rain Barrel Workshops are being planned in collaboration with local Soil & Water Conservation Districts and Virginia Cooperative Extension offices to promote water conservation through hands-on community events.
- Tree Giveaway Events are in the works through a developing partnership with the Virginia Department of Forestry (VDOF) to increase canopy coverage and promote native species planting.
- CRC is organizing a "Get Funded: Environmental Grants" Workshop, where localities will connect with representatives from state agencies to learn about available environmental funding opportunities.
- CRC has also signed on to support DEQ's development of the Chowan River I
  Water Supply Plan, a collaborative effort to ensure long-term water availability
  and sustainability for participating communities.

# Public Input Shaping Local Comprehensive Plans

CRC continues to support local planning through active Comprehensive Plan updates in multiple communities:

- Town of Drakes Branch recently hosted its first round of community meetings and is preparing to launch a public input survey to gather additional feedback on the town's future development goals.
- Amelia County is conducting three upcoming community meetings over the next month and is working through detailed plan sections in coordination with the Planning Committee during monthly work sessions.

These efforts ensure local voices are at the center of long-term planning and land use decisions across the region.
